

SCB Oceania Chapter Grants

Purpose

The SCB Oceania Chapter Grants exist to support activities organised by our Chapters that will further the [goals](#) of the SCB Oceania Section and/or will expand and diversify our membership.

SCB Oceania seeks to promote conservation science within Oceania, to build the capacity of conservation students within our region, and to make conservation science accessible to the public. We seek to ensure that environmental policies at local, regional, national, and international levels are informed by the best available scientific evidence. The SCB Oceania Chapter Grants recognise the unique ability of our Chapters to engage with and lead local initiatives that will promote the Society and improve our capacity to achieve these goals.

Funding Rules

- Each Chapter¹ may apply for one grant per year.
- Grants of up to \$500 AUD can be awarded (less than \$500 may be requested; a budget must accompany each application).
- Applications will be assessed by the Board on a rolling basis; the Board meets every two months, so please allow time for your application to be reviewed and approved.
- Grants will be assessed on their perceived likelihood of successful outcomes, contribution to SCB Oceania goals, and potential to promote the Society and grow our membership. Any decision to award a grant is at the discretion of the Board.
- Funds will be disbursed to an approved Chapter operating account upon grant approval

Notes

We encourage Chapters to apply for funding from local sources to support their activities, and will look favourably on applications for matching or top-up funds. A list of potential funding sources is available [here](#). Note that [SCB Global](#) offers two rounds of [Chapter Grants](#) annually. If an Oceania Chapter successfully applies for a global Chapter grant, the Oceania Section can provide a top-up of an additional \$500 AUD. If you would like help in preparing an application, please [contact us](#).

We want to help make your event or project a success. To help us help you, we will ask grant recipients to provide promotional materials so that we can advertise their activity online and through our social media a few weeks beforehand. We also request that grant recipients provide a short report or blog piece for our [newsletter](#) following their activity.
